

Key information for small commercial passenger vessels carrying forestry workers



Carrying workers on any vessel makes it a commercial passenger vessel

Make sure you register your vessel accordingly. Regulations are relative to **the size** (gross tons/length) and **use of the vessel**, <u>not</u> what it was designed for, or how it is currently registered. Any pleasure craft, crew boat, accommodation or fishing vessel, or even human powered vessel (e.g. row boat) that is used to transport workers is legally defined as a Commercial Passenger Vessel.

Never carry more than allowed: there is a difference between passenger rating and capacity

Small Vessel Operator Proficiency Course (SVOP) provides a passenger rating (how many passengers you are authorized to carry) and does not include the crew necessary to operate the vessel, typically one or two on a small crew boat. For example, your SVOP may allow for 12 passengers plus required crew. However, the Capacity Label of a vessel is for all people on board. You may not carry more than your rating <u>and</u> capacity label allows.

You must be trained for vessel size, passenger and crew count, and water type in BC. All the training and certificate requirements are the same except for 5 GT or less, 8 m long or less in sheltered waters where only a PCOC is needed:

Notes: *Gross tonnage (GT) may be measured in three ways: assigned, simplified and by a duly appointed tonnage measurer. **Regarding Marine FA level 1 vs OFA level 1 with transportation endorsement: WorkSafeBC First Aid requirements may be different for the 'work site', but those requirements may be acceptable to meet Transport Canada requirements.
