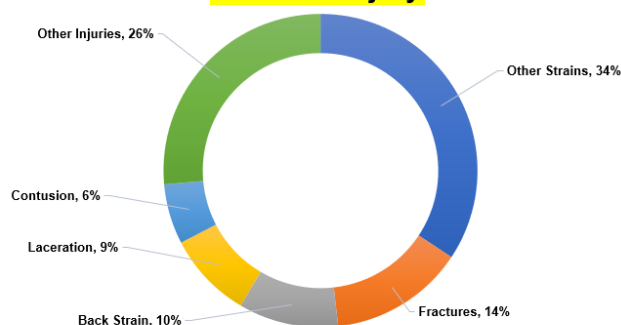

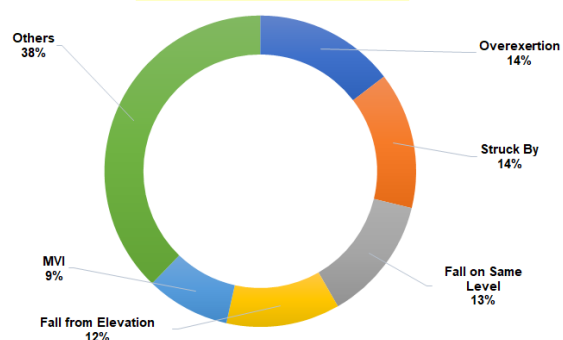

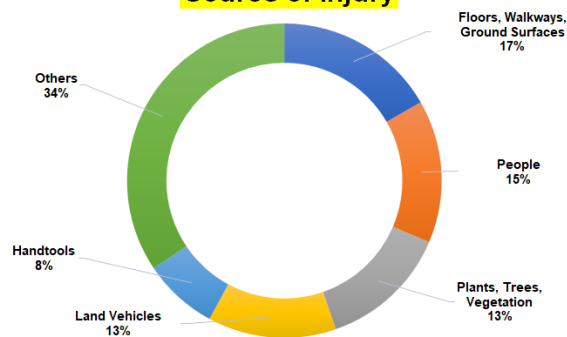
Nature of Injury



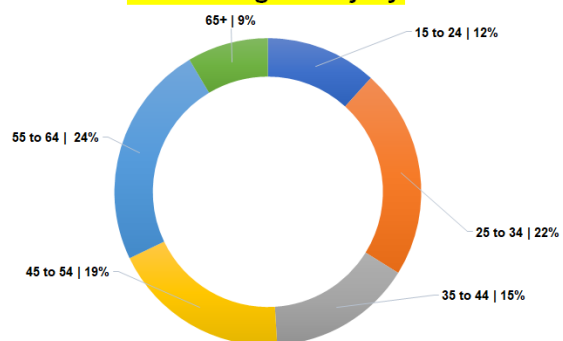
Mechanism of Injury

Worker Age at Injury



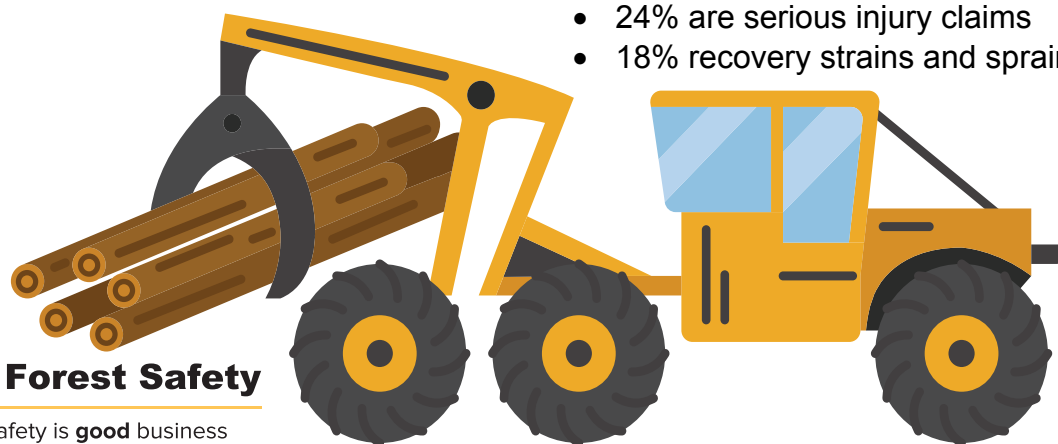
Quick Facts

- 18% recovery strains and sprains



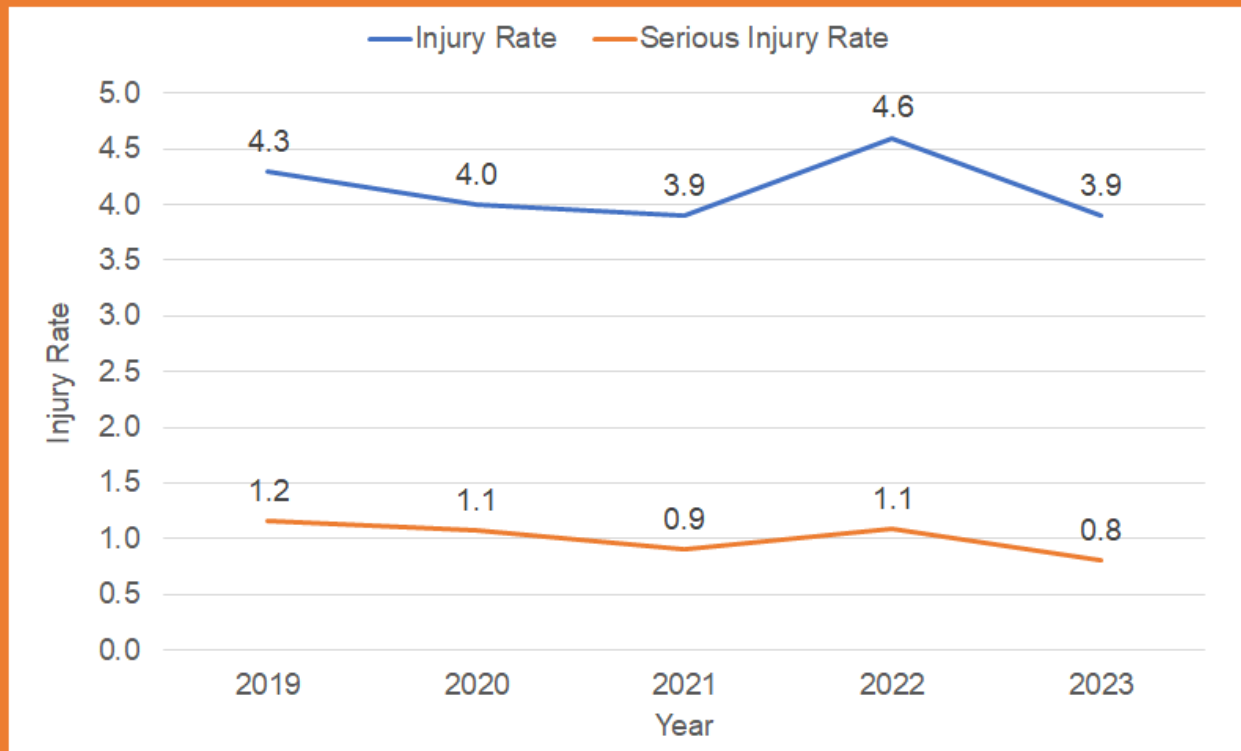
