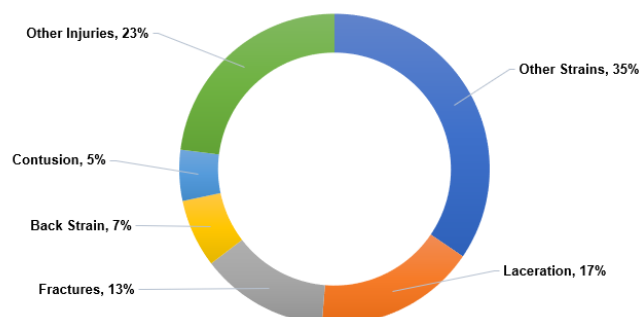

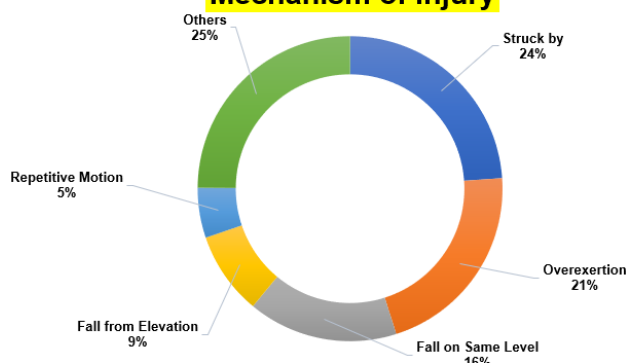

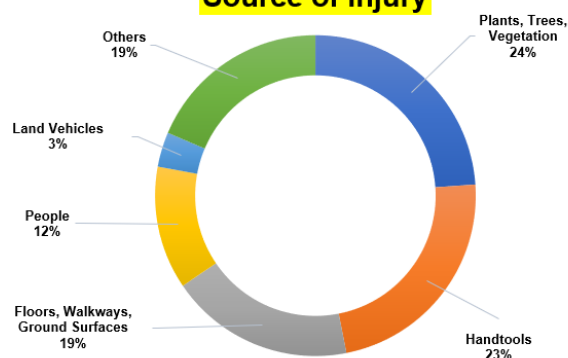
Nature of Injury



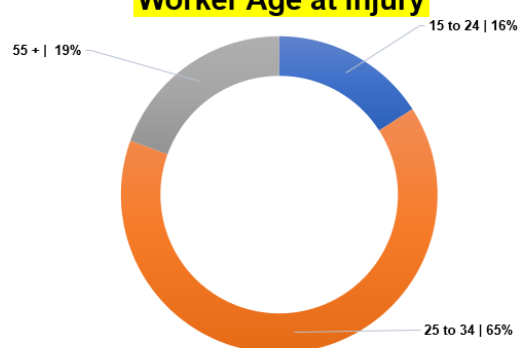
Mechanism of Injury

Worker Age at Injury



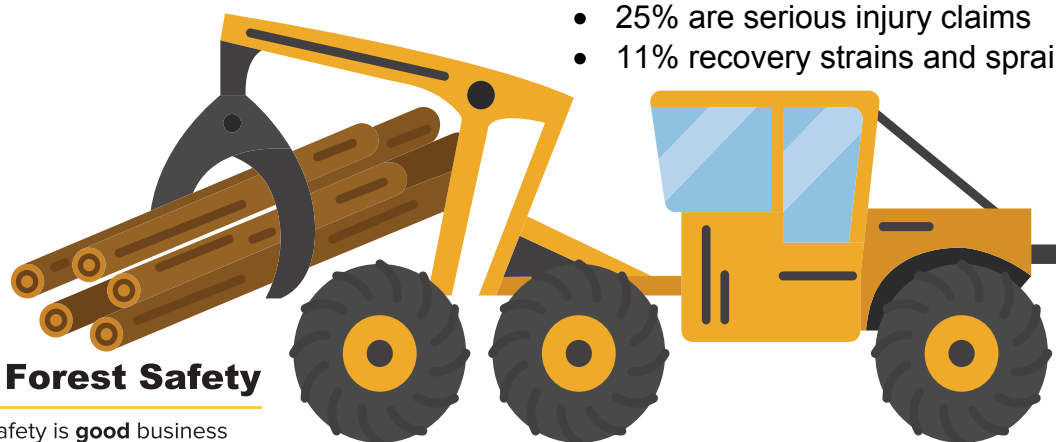

- 11% recovery strains and sprains



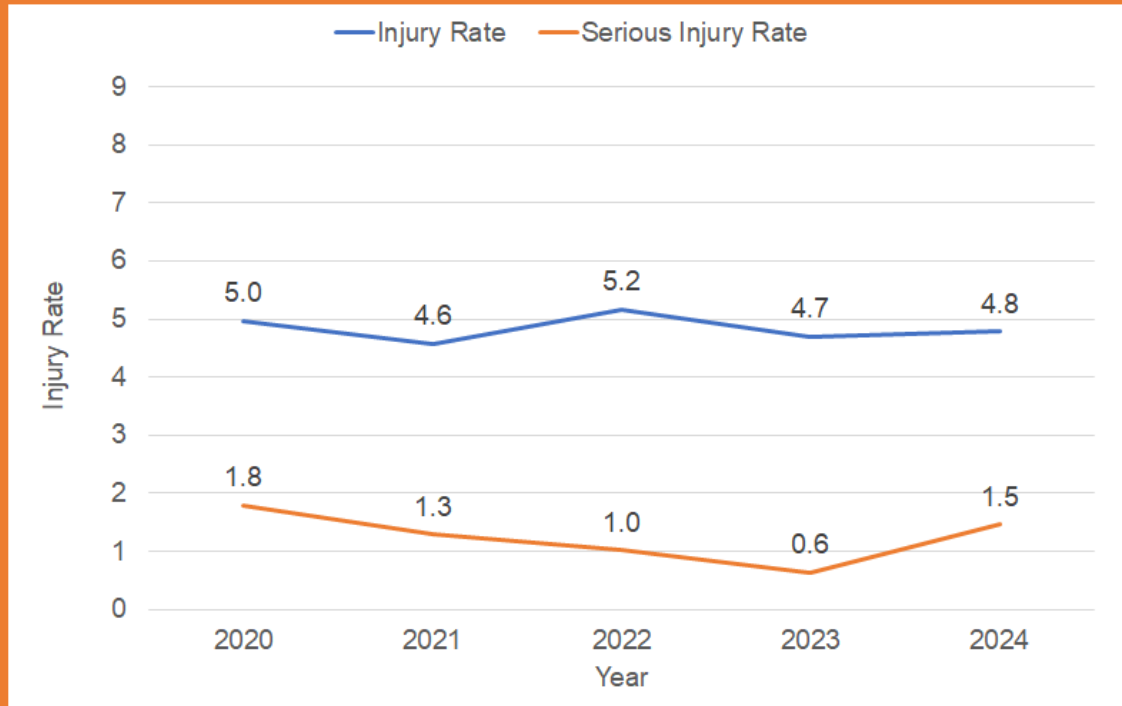
